Item 1, being:

CONTINUED DISCUSSION REGARDING THE EVALUATION OF CITY FEE STRUCTURE AND REVENUE MANUAL.

The Committee agreed to the staff sending out one more email to the City Council members about which fees should be investigated, and after that, the staff can proceed with research into any fee structures they would like.

Item 2, being:

DISCUSSION REGARDING A POSSIBLE AMENDMENT TO SECTION 8-203 OF THE CODE OF ORDINANCES RELATED TO CITY COUNCIL'S APPROVAL OF PURCHASES.

Francisco stated that the discussion today is about whether to keep the level of Council approval for City contracts at \$25,000 and above or increase it to State statute level, or any other amount.

Chair Wilson asked if there are any problems with the current level. Francisco stated that there are no concerns, but there is some consensus that the current level is too low. Wilson stated that she worries about the optics of changing this level. Public Works Director O'Leary stated a concern with mundane matters clogging the Council agenda, with related staff time.

Committee members agreed to send the issue to the City Council via email with the recommendation to change the ordinance to line up with State statute level for competitive bidding.

SUBMISSION OF THE REVENUE/EXPENDITURE REPORTS

Francisco stated that the sales tax collection is 0.87% above last fiscal year, which is still below our budgeted projection. The General Fund is above the projected expenditures almost entirely due to the \$5 million transfer made to front the Transit takeover. We hope that some of that money will come back to the General Fund via the Federal Transit Grant.

Shawn O'Leary stated that we have made strides in getting the \$2 million from the Transit Grant. We currently hope to get this for this fiscal year.
