### Public Roadway, Drainage and Utility Easement

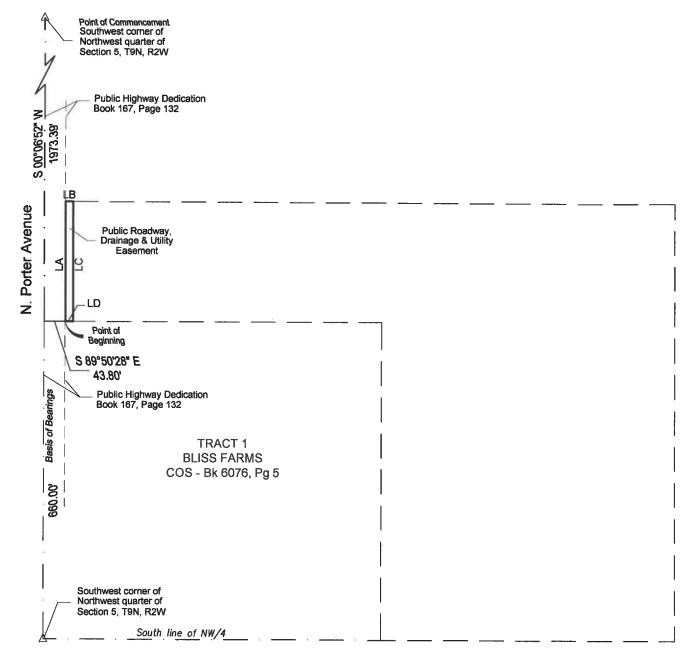

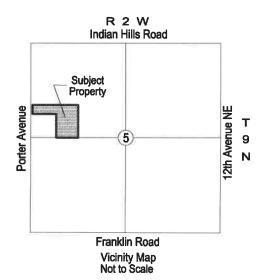
