DISCUSSION AND REVIEW OF OUTSIDE AGENCY REPORTS AND/OR REQUESTS

Francisco stated that the discussed agencies are outside agencies from the City of Norman that receive support from the General Fund. None of the requesting agencies are requesting an increase except for the Performing Arts Studio.

Council Member Wilson asked what the increase amount requested by the Performing Arts Studio was. Francisco stated that it was an increase of \$1,500.

Council Members Petrone and Wilson both stated that they would be interested in seeing a breakdown of the request by Select Norman.

Mayor Clark stated that she does not want to cut any of the outside agency funding. Council Member Wilson stated that she would push back on any request for increase in the funding.

Item 1, continued:

Maureen Hammond from Select Norman stated that they are preparing an annual report that should break down exactly what they do with the funding they receive. This should be done within the next three weeks.

Council Member Petrone stated she was unsure about the City giving funding to religious entities. Kathryn Walker stated that the contract with those entities states they cannot use the funds for anything faith-based and they can only be used for the social services they provide.

Mayor Clark stated that the Committee would like to ask the Arts Roundtable to provide additional funding out of the arts portion of the Room Tax Fund so that the City can decrease its funding for arts agencies out of the General Fund. Council Member Wilson suggested that funding for Visit Norman could be reduced and transferred to the arts portion.
